## WHAT ARE THE BENEFITS OF HAVING PEER MEDIATION IN YOUR SCHOOL?

#### SCHOOL STAFF

- Staff spends less time settling disputes
- Decreases the pressure on teachers to serve as constant disciplinarians
- Reduces tension among staff and students
- Improves overall school climate through better student-staff relationships

### STUDENTS

- Become active in the problem-solving
  process
- Are lead to greater commitment to making solutions work
- Are provided with positive role models for solving conflicts
- Assume greater responsibility for solving their own problems
- Recognize that adult intervention is not always necessary
- Mediation process encourages students to share their feelings and search for constructive ways to meet their needs

### FAMILIES

- Mediation process carries over to families
- Peer Mediators use their problem solving skills at home with their siblings and significant others

# WHAT IS THE PEER MEDIATION PROGRAM?

In peer mediation, student mediators are taught a process of communication and problem-solving that they apply to help their peers reach settlements of their disputes without confrontation and violence.

## WHAT KIND OF DISPUTES DOES PEER MEDIATION HANDLE?

- Rumor and gossip
- Relationship difficulties/harrassment
- Racial and cultural confrontations
- Minor assaults and fights
- Cheating and stealing
- Vandalism
- Classroom or extracurricular disputes

## WHO ARE THE STUDENT MEDIATORS?

Student mediators are representatives of your school. The students are selected and trained in Conflict Resolution and Neutrality.

## WHAT ARE THE BENEFITS OF PEER MEDIATION TRAINING?

- Improves school climate

- Motivates students to resolve their conflicts collaboratively
- Engages all students, even those considered "at-risk"
- Deepens the educational impact of school
