January was Human Trafficking Awareness Month. <u>EAC Network's Safe Harbour program</u> organized a public conference on January 25, 2023, at the Suffolk County Bar Association to raise awareness.

Many experts educated a large audience about the resources available to protect children of Suffolk County from human trafficking and sexual exploitation.

Among the panelists were the EAC Network Safe Harbor program staff, Suffolk County Police Department, Suffolk County Child Advocacy Center, Suffolk County District Attorney's Office, and Child Protective Services. Safe Harbour advocates for and supports children that have been, or are at risk of being, sexually exploited in Suffolk County. Our goal is to provide the education, skills, and support needed for these children to lead safe and meaningful lives.

A two-hour training on "Identifying Child Abuse" took place at <u>EAC's East End Child Advocacy Center (EECAC)</u>, 940 Roanoke Avenue, Riverhead, on January 27th, 2023.

The training was organized to provide the East End law enforcement partners with comprehensive information related to the medical diagnosis of all forms of child maltreatment including child sexual abuse, child physical abuse, and neglect. The aim of this education is to enhance police investigations of child abuse and neglect and to encourage collaboration through the services offered at the Child Advocacy Center.

"EAC's Child Advocacy Center protects children from both the short and long-term effects of trauma from sexual abuse. While providing a path towards emotional healing and recovery, we work closely with Suffolk County's Police Department and Eastern Long Island Police Departments to coordinate forensic interviews by utilizing evidence-based practices that facilitate better outcomes when cases reach prosecution." said Neela Mukherjee Lockel, EAC Network's President and CEO.

The Identifying Child Abuse Training was conducted by Dr. Gillian Hopgood, board-certified Child Abuse Pediatrician at Stony Brook Children's Hospital and the Medical Director of the Suffolk County Child Advocacy Center.

"Child abuse is a generally trivialized and misunderstood societal issue that unfortunately represents a significant public health problem that can have lasting effects on children and their families," said Dr. Gillian Hopgood."
