#### **SCHOOL STAFF**

- Staff spends less time settling disputes •Decreases the pressure on teachers to serve as constant disciplinarians
- Reduces tension among staff and students Improves overall school climate through better student-staff relationships

#### **STUDENTS**

- Become active in the problem-solving process
- Are led to greater commitment to making solutions work
- Are provided with positive role models for solving conflicts
- Assume greater responsibility for solving their own problems



## What is Peer Mediation Programming?

In peer mediation, student mediators are taught a process of communication and problem-solving that they apply to help their peers reach settlements of their disputes without confrontation and violence.

## What types of Disputes does Peer Mediation Handle?

- 1. School Rumors and gossip
- 2. Social media/networking Provocations
- 3. Dissolution of friendships & relationships
- 4. Confrontations regarding differences in race, culture, sexual orientation, & religion
- 5. Minor bullying/harassment
- 6. Cheating and stealing
- 7. Vandalism
- 8. Classroom or extracurricular disputes

## Who are the Student Mediators?

Student mediators are representatives of your school. The students are selected and trained in mediation and Neutrality.
